A. Opening remarks, introduction of the CRSC Steering Committee and Summary of CRSC activities

A summary of CRSC activities and progress since the last CRSC meeting was provided.

B. Metrics Platform/CRSC - What next?

The Metrics Platform was launched on March 28th. This session was used to explore options for communications and engagement of stakeholders to ensure optimum use of the Metrics Platform and other work of the CRSC. [Click here to view the presentation.](#)

Follow-up: CRSC to identify and work with at least one association and one company as “test cases” to determine what type of communications products are most helpful to understand and use the Metrics Platform. “Test cases” to be recruited by end of June 2018 and work will be conducted until September 2018.

Using the results of the “test cases”, communications and engagement products will be developed and distributed throughout the fall-winter 2018/19.

CRSC Members will self-identify or nominate potential “CRSC Metrics Platform ambassadors”. CRSC Communications Committee and staff will develop and test introductory Metrics Platform material that could be used by the “Ambassadors”, and work with each “Ambassador” to plan and execute outreach activities during the next year.

C. SAI Platform Farm Sustainability Assessment

The SAI FSA can be an important benchmarking tool for sustainability initiatives. Grain Farmers of Ontario initiated a submission of the Canadian and Ontario legislation impacting grain production in 2017, which achieved Bronze status. Since then, various groups have prepared submissions for Quebec, Manitoba, Saskatchewan and Alberta. This session covered what these submissions entailed, how the benchmarking results can be used by industry; and why various industry groups selected SAI and how they intend to use the results.
